- A postcard postmarked in Elkins May 1, 1919 from Elsie Stearns to her mother Mrs. John K. Stearns. The card is of the gazebo in Willow Park, Elkins, NH and was published by George Thurston who owned the store in Elkins. Donated by Dean Smith via Luan Clark, Andover Historical Society
- A 1905 "Merry Christmas Souvenir Wilmot Flat School". Handmade booklet tied with a red ribbon, a poem inside and red and green Holly branches sketched on the cover. Made by Ruth Phelps. Donated by Luan Clark
- A black-and-white postcard published by Geo. Thurston of "Kearsarge mountain from Elkins New Hampshire" addressed to Mrs. John Stearns Wilmot, NH September 10, 1919. Poor shape, stained with the corners worn off including the name of the sender. Donated by Luan Clark
- A colored print of the photo of Branch Bridge Road in Wilmot, N.H. which has been used on postcards. Torn/worn on one corner. Donated by Luan Clark
